Paper Writers' invitation and guide for abstracts preparation

The author of each accepted paper will be required to present respective paper in the conference venue.

- b) The abstract content and learning experiences should be consistent with the theme and focus on one of the sub-themes highlighted hereunder;
- c) Plagiarism is an unacceptable professional misconduct and cannot be tolerated. If an author is found to commit an act of plagiarism, the paper will be rejected at any process. and
- d) Authors will not be allowed to send a representative to present his/her paper on their behalf.
