Matumizi ya kidigitali hayaepukiki sekta ya ununuzi na ugavi

SERIKALI imesema ili kuendana na kasi ya mabadiliko ya kidijiti duniani, sekta ya ununuzi na ugavi haina budi kuyakumbatia matumizi hayo katika shughuli zake za kila siku ikiwemo usajili na uombaji wa zabuni mbalimbali.

Naibu Waziri Mkuu ambaye pia ni Waziri wa Nishati, Dk Dotto Biteko alisema hayo Desemba 17, 2024 wakati akifungua Kongamano la 15 la Bodi ya Wataalam wa Ununuzi na Ugavi nchini (PSPBT) lililofanyika katika Kituo cha Kimataifa cha Mikutano cha Arusha (AICC).

Kaulimbiu ya kongamano hilo ni 'Mabadiliko ya Ununuzi na Ugavi kwa Usimamizi Bora wa Rasilimali'.

Alisema kaulimbiu hiyo inaendana na mabadiliko ambayo serikali imeendelea kuyafanya ikiwemo matumizi ya mfumo wa manunuzi na ugavi wa kieletroniki (NeST) ambao umesaidia kutoa huduma bora na ya haraka zaidi.

"Napongeza mfumo wa usajili wa wataalam wa ununuzi na ugavi kwa njia ya mtandao unasomana na mfumo wa NeST, mfumo huu utahakikisha shughuli za ununuzi na ugavi zinafanywa na watu wenye sifa stahiki waliosajiliwa na PSPTB, hatua hii pia itasaidia kwenye udhibiti wa weledi na wataalam wanaotumia mfumo huu na waliosajiliwa na bodi," alisema Dk Biteko.

Hivyo alisisitiza wasimamizi wa sekta hiyo kuongeza weledi na kuwaondoa watumishi wasio na vigezo.

Dk Biteko alisema serikali kupitia bajeti kuu ya serikali kwa mwaka wa fedha 2024/2025 ilitoa dira ya kuhakikisha ununuzi unafanyika kwa njia ya mtandao na kwa kuzingatia bei ya soko.

Hatua hiyo ni kupunguza gharama katika sekta ya manunuzi ya umma na kuleta tija kwa Watanzania na taifa kwa ujumla, hivyo kila sekta imetakiwa kuendana na dira hiyo.

Makamu Mwenyekiti wa Bodi ya PSPTB, Benezeth Ruta alisema bodi hiyo inapaswa kuongezewa nguvu ya rasilimali watu ili kuendana na kasi ya matumizi ya teknolojia na kuondokana na ubadhilifu ambao umekuwa ukifanywa na baadhi ya watumishi wasio na weledi wa masuala ya ununuzi na ugavi.

Alisema hatua hiyo ni hatari kitaaluma kwa sababu hauleti tija katika eneo la ununuzi na ugavi na matokeo yake ni kusa-

babisha upotevu wa fedha za umma.

"Mabadiliko ya kidijiti hayakwepeki katika dunia ya leo, katika ukaguzi unaoendelea PSPTB imebaini kuna upungufu mkubwa wa wataalam wenye sifa stahiki hususani katika halmashauri za miji, wilaya na manispaa nchini," alisema Ruta.

Alisema upungufu huo umesababisha baadhi ya halmashauri na taasisi za

umma kutumia watumishi wasio na sifa za taaluma hiyo kufanya kazi za manunuzi ya ugazi jambo ambalo ni nje ya taaluma hiyo na ni kinyume na kifungu cha 11 cha sheria ya PSPTB.

Kongamano hilo limewakutanisha wadau mbalimbali katika sekta ya ununuzi na ugavi nchini kutoka sekta ya umma na binafsi.

Naibu Waziri wa Fedha, Mhe. Hamad Chande (Mb.) akihutubia washiriki wa Kongamano la 15 la Wataalam wa Ununuzi na Ugavi lililofanyika katika Kituo cha Mikutano cha Kimataifa cha Arusha (AICC) Jijini Arusha.

WATAALAMU wa ununuzi na ugavi nchini wamesisitizwa kulinda maadili ya kazi na kusimamia upatikanaji wa haki kwa wote na kuepuka kutoa zabuni kwa upendeleo na rushwa kwenye miradi ya maendeleo.

Naibu Waziri wa Fedha, Hamad Chande Hamad alisema hayo wakati akifunga Kongamano la 15 la Bodi ya Wataalamu wa Ununuzi na Ugavi nchini (PSPBT) lililofanyika katika Kituo cha Kimataifa cha Mikutano cha Arusha (AICC).

Aliwataka wataalamu hao kutumia vyema taaluma zao kuleta tija katika manunuzi mbalimbali ya umma.

Alisema sekta hiyo inapaswa kusimamia utoaji huduma bora kwa Watananzania kufanya ununuzi unaozingatia thamani ya fedha, upatikanaji wa vifaa na malighafi ambazo zimekuwa zikitunga katika miradi mbalimbali nchini.

"Ndugu zangu washiriki wa kongamano hili naomba mtambue serikali haitamvumilia yeyote atakayeshiriki

vitendo visivyo vya kimaadili na kitaaluma, tutachukua hatua kali, tunawaasa muwe waadilifu na tekelezeni majukumu yenu inavyopaswa," alisisitiza Chande.

Kadhalika aliwataka washiriki hao kuendana na matumizi ya mifumo ya kieletroniki ambayo imeendelea kuanzishwa na serikali ili kuepuka upotevu wa rasilimali fedha pamoja na ubadhilifu katika ununuzi na ugavi serikalini.

Nimefarijika sana kusikia mada kuu ya kongamano ikijielekeza kujadili mabadiliko ya kigiti, naamini majadiliano mliyofanya yataleta tija katika kuboresha mfumo wa ununuzi na ugavi kwa njia ya mtandao," aliongeza Chande.

Makamu Mwenyekiti wa Bodi ya Wakurugenzi ya PSPTB, Benezeth Ruta alisema mada zilizowasilishwa katika kongamano hilo ikiwemo, kujenga uchumi shindani kupitia mnyororo wa ununuzi na ugavi zitaleta mabadiliko na utendaji wenye tija kwa wananchi na

serikali kwa ujumla.

"Ni jukumu la kila mmoja wetu kufanya kazi kwa bidii na kuzingatia maadili ili tuweze kuifikisha nchi yetu kwenye uchumi wa viwanda na kuleta maendeleo ya wananchi wa taifa, bodi tunatoa rai kwa wataalamu wetu wote muwe wazalendo katika kutimiza wajibu wenu," alisema Ruta.

Kongamano hilo la 15 la mwaka la wataalamu wa ununuzi na ugavi lilianza Desemba 17, 2024 na kufikia tamati Desemba 19, mwaka huo mjini Arusha.

Liliwakutanisha zaidi ya washiriki 1,800 wa sekta hiyo kutoka idara na taasisi mbalimbali za serikali pamoja na sekta binafsi.

Mada mbalimbali katika kongamano zilijadiliwa ikiwemo kubainisha vichocheo na vikwazo vya mabadiliko ya mnyororo wa ununuzi na ugavi, nafasi ya ununuzi na ugavi kwa usimamizi bora wa rasilimali, usimamizi wa miradi inayofadhiliwa kupitia mabadiliko ya ununuzi na ugavi.

Wahitimu wa ununuzi na ugavi wahimizwa kujisajili kidijiti

WAHITIMU wa masomo ya ununuzi na ugavi nchini wamehimizwa kujisajili kidijiti ili waweze kufanya mitihani ya kitaaluma pamoja na kutambulika kitaaluma.

Hayo yalibainishwa Mei mwaka huu na viongozi wa Bodi ya Wataalamu wa Ununuzi na Ugavi nchini (PSPTB) waliotembelea vyuo vinavyotoa mafunzo hayo katika mikoa mitatu nchini.

Bodi hiyo imewahimiza zaidi wanafunzi kujisajili kwa njia ya mtandao hususani kuwa mwanachama wa bodi hiyo lakini pia wajisajili ili waweze kufanya mitihani ya bodi ambayo hutolewa kwa wanachama wake.

Vyuo vilivyotembelewa ni vya mkoani Dar es Salaam, Morogoro na Iringa na ziara hiyo ni utekelezaji wa mpango mkakati kwa mwaka wa fedha 2024/2025 unaohamasisha wana-taaluma wa fani hiyo kujisajili na kutambuliwa.

Mkufunzi wa Chuo cha Bahari Dar es Salaam, Dk Julieth Kwashuma alisema mafunzo yaliyotolewa kupitia ziara hiyo yataendelea kuwaweka wanafunzi karibu na bodi hiyo ili kurahisisha kujifunza na kupata huduma mbalimbali zitolewazo na bodi hiyo.

“Matakwa ya sasa ya ajira kwa kada ya ununuzi na ugavi lazima muombaji awe anatambulika na bodi ya ununuzi kwa hiyo tunaamini kwamba wanafunzi wetu wameelewa na watakuwa watiifu na elimu hii itawasaidia kwenenda kulijenga taifa letu,” alisema Dk Kwashuma.

Ziara hiyo ilikuwa na malengo yake ni kuongeza idadi ya wataalamu wa sekta ya ununuzi na ugavi waliosajiliwa, kuhimiza wanafunzi wanaohitimu masomo yao kujisajili kwa ajili ya mitihani ya kitaaluma pamoja na uanachama.

Aidha ziara hiyo ililenga kuimarisisha uhusiano kati ya PSPTB na vyuo vilivyopo chini yake.

Vyuo vilivyotembelewa ni pamoja na Chuo Kikuu cha Taifa cha Usafirishaji (NIT), (Dar es salaam), Chuo cha Bahari Dar es Salaam (DMI), Chuo cha Kumbukumbu cha Mwalimu Nyerere (MNMA), Chuo cha Teknolojia cha Kilimanjaro (KITM) na Chuo cha Elimu ya Biashara (CBE)-Dar es Salaam.

Mkoani Morogoro vyuo vilivyotembelewa na viongozi wa PSPTB ni pamoja na Chuo Kikuu cha Kiislam Morogoro (MUM) na Chuo Kikuu cha Mzumbe.

Iringa walitembelea Chuo Kikuu cha Mkwawa na Chuo Kikuu cha Tumaini.

Katika vyuo hivyo zaidi ya wanafunzi 1,000 wanaosoma fani hiyo kuanzia ngazi ya Astashahada, Stashahada na Shahada walipata mafunzo ushauri huo.

Mbanyi alisema bajeti ya mwaka 2024/2025 inakamilika Juni 30, 2025 hivyo ni wajibu wa menejimenti kulieleza baraza hilo mafanikio, changamoto na njia za utatuzi na vipaumbele vya bajeti ijayo.

Wanataaluma ununuzi na ugavi wa TAA wapigwa msasa

WATUMISHI 84 wa Mamlaka ya Viwanja vya Ndege (TAA) wamepewa mafunzo ya Sheria Mpya ya Ununuzi na Ugavi ya mwaka 2023 na kanuni mpya za mwaka 2024 yanayowajengea uwezo wa kutekeleza majukumu yao kwa weledi.

Mafunzo hayo yameendeshwa na Bodi ya Wataalamu wa Ununuzi na Ugavi (PSPTB) na kufanyika katika ukumbi wa Kiwanja cha Kimataifa cha Julius Nyerere (JNIA), Dar es Salaam.

Akizungumza wakati wa kufunga mafunzo hayo, Mkurugenzi Mkuu wa TAA, Abdul Mombokaleo alisema mafunzo hayo yamewasaidia watumishi hao kujiamini katika kutekeleza majukumu yao kwa maslahi ya taifa.

Mombokaleo alisema ili kusaidia wanataaluma hiyo kazini wamedhamiria kuendelea kuwapa mafunzo ya usimamizi wa mikataba ya ununuzi kwa lengo la kuwajengea uwezo na ufahamu wa kusimamia miradi mbalimbali ya taasisi.

Mkurugenzi wa Huduma za Uanachama na Taaluma wa PSPTB, CPSP(T) Amos Kazinza alisema wametoa mafunzo hayo kwa kuzingatia Sheria ya Ununuzi wa Umma ya mwaka 2023 na kanuni mpya za mwaka 2024.

Alisema jumla ya watumishi 84 wa sekta ya ununuzi na ugavi wa TAA kutoka kanda mbalimbali za mamlaka hiyo wamenufaika na mafunzo hayo.

"Sheria ya ununuzi na ugavi imekuwa na mabadiliko mengi ambayo inawataka wajumbe bodi ya zabuni waweze kuidhinisha baadhi ya manunuzi kulingana na ukomo wa uidhinishaji," alisema CPSP(T) Kazinza. Pia alibainisha kuwa katika mabadiliko ya sheria hiyo inamtaka

mhasibu aawajibike kuidhinisha manunuzi kulingana na ukomo wa uidhinishaji.

Katika sheria hiyo pia inawataka wataalamu wa ununuzi na ugavi kufanya ugavi, awali lilikuwa kwenye sheria ya fedha na kuwa baada ya sheria kufanyiwa marekebisha wataalamu hao

wana jukumu la kufanya ununuzi na ugavi ili kuhakikisha mnyororo wa ugavi unasimamiwa vizuri.

"PSPTB inawajibika kuhakikisha kwamba wadau wote wanaosimamia ununuzi na ugavi wanapata uelewa wa pamoja ili kuhakikisha thamani ya fedha inaonekana kwa kila mradi unaotekelezwa na taasisi au mamlaka," alisema CPSP(T) Kazinza.

Kazinza ametoa wito kwa taasisi za umma na binafsi ya kuona fursa hii ya kuwajengea uwezo wataalamu wao kwasababu ya sehemu kubwa ya matumizi ni ununuzi.

PSPTB yaendesha mitihani 30 ya kitaaluma

BODI ya Wataalamu wa Ununuzi na Ugavi (PSPTB) imeendesha mitihani yake ya 30 kwa watahiniwa zaidi ya 1,000 katika ngazi za tofauti za kitaaluma hiyo.

Akizungumzia mitihani hiyo iliyo-fanywa katika mikoa saba nchini Mei mwaka huu, Afisa Mitihani wa PSPTB, Faraja Mgulambwa alisema mitihani hiyo imefanywa katika mikoa ya Dar es Salaam, Dodoma, Kilimanjaro, Arusha, Mbeya, Mwanza na Zanzibar kati ya Mei 12 hadi 16, mwaka huu.

Alisema ili kupata sifa za kitaaluma ni lazima wahitimu kutoka vyuo mbalimbali wajisajili na kufanya mitihani ya bodi ili kupata vigezo vya kufanya kazi hiyo.

Faraja aliwasisitiza waajiri kutoajiri watumishi wa manunuzi na ugavi wasio na sifa stahiki hususani wale ambao hawajafanya mitihani ya kitaaluma na kuwa na ujuzi na maarifa stahiki.

"Bodi iko macho na hatua stahiki za kisheria na kimaadili zitaendelea kuchukuliwa kwa wale wanaokiuka sheria, kanuni na matakwa ya maadili ya utendaji kazi," alisema Faraja.

Alisema hatua hizo zitachukuliwa kwa wataalam wa fani hiyo na wengine wote wanafanya kazi za ununuzi na ugavi bila kuwa na sifa stahiki ambazo ni pamoja na kusajiliwa bodi na kufanya mitihani.

Hivyo alitoa mwito kwa wanataaluma hao ambao bado hawajajisajili wafanye hivyo na kufanya mitihani ya bodi itakayofanyika Novemba mwaka huu.

Pia aliwasisitiza waajiri wenye watumishi wanaopaswa kufanya mitihani ya kitaaluma ili kuwa sifa zinazohitajika, wawape ruhusa watumishi hao ili waweze kujiendeleza na kuwalipia ada za mafunzo na mitihani ya kitaaluma.

Alisema sekta hiyo ina mchango mkubwa katika maendeleo ya nchi, kwa sababu inatoa nafasi nyingi za ajira ajira serikalini na katika sekta binafsi.

Aidha, alibainisha sekta hizo mbili zinategemea wataalamu wa ugavi waliothibitishwa na kusajiliwa na bodi hiyo hivyo ni muhimu kwa wanafunzi kuzingatia viwango vya taaluma na maadili ya kazi ili kuwa na ushindani katika soko la ajira.

Baada ya mafunzo hayo, wanafunzi walipata fursa ya kuzungumza na kueleza maoni yao kuhusu sekta ya hiyo pamoja na changamoto wanazokutana nazo katika masomo yao.



Wanafunzi 243 wanufaika na mafunzo ya tafiti

WANAFUNZI zaidi ya 243 wa fani ya ununuzi na ugavi kutoka mikoa mitano nchini wamepata mafunzo na mbinu maalum za kuwaandaa kuandika andiko la tafiti zitakazoleta matokeo chanya kwa sekta hiyo.

Akizungumza wakati wa ufunguzi wa mafunzo hayo Mkurugenzi Mtendaji wa Bodi ya Wataalamu wa Ununuzi na Ugavi (PSPTB), Godfrey Mbanyi alisema mafunzo hayo ni moja ya matakwa ya fani hiyo kwa wanataalamu wa sekta hiyo.

"Takwa mojawapo kwa wanafunzi hawa ni kuhudhuria semina na kupata mafunzo yatakayowapitisha kwa usahihi katika safari yao ya kufanya tafiti na kuhitimu vyema ma-

funzo hayo wakiwa wamepikwa na kuiva vizuri," alisema Mbanyi.

Wanafunzi hao ni kutoka Kilimanjaro, Mtwara, Mwanza na Dar es Salaam.

Alisema katika mafunzo hayo wanafunzi hao wanajengewa uwezo wa kuandika tafiti na ripoti mbalimbali kwa kufuata kanuni na miongozo ya PSPTB.

Bodi ya Wataalam wa Ununuzi na Ugavi kupitia kifungu cha 7 (e) na (f) cha Sheria ya PSPTB No. 23 ya mwaka 2007 imeanzisha mafunzo maalum ya kuandaa wakaguzi wa mnyororo wa ununuzi na ugavi. Mafunzo

haya pamoja na kukidhi matakwa ya Sheria tajwa pia yameanzishwa ili kutekeleza mwongozo wa usajili wa PSPTB wa kusajili wataalam wa ukaguzi katika tasnia ya ununuzi na ugavi.

Malengo mahususi ya mafunzo ya ukaguzi katika tasnia ya ununuzi na ugavi yamejikita kuwawezesha washiriki; kupata ujuzi na mbinu za ukaguzi katika utendaji wa mnyororo wa ununuzi na ugavi, kujua kanuni za maadili na viwango vya taaluma ya ukaguzi, kutambua sifa za kupata ithubati na usajili wa wakaguzi wa ununuzi na ugavi, kuimarisha weledi na utendaji wa kitaalamu katika ukaguzi wa tasnia ya ununuzi na ugavi, kutoa fursa kwa wahitimu kuanzisha kampuni za shughuli za ukaguzi katika tasnia ya ununuzi na ugavi katika sekta ya umma na binafsi na kukuza stadi za uongozi katika timu za ukaguzi na utamaduni wa kujitegemea.

Mafunzo ya ukaguzi yamefanyika kati-

ka awamu mbili katika mwaka wa fedha 2024/2025 kwa mafunzo ambapo jumla ya washiriki 131 wamepatiwa mafunzo. Bodi ina Imani kubwa na weledi na uwepo wataalam hawa na kwamba kwa kushirikiana na mam-laka zingine nchini, uwepo wao utasaidia sana utendaji na ufanisi wasekta ya Ukaguzi na hususani eneo la Ununuzi na Ugavi.

MITHANI YA 30 YA PSPTB

Bodi katika kutekeleza majukumu yake imeendesha mitihani ya Taaluma ya Ununuzi na Ugavi nchini kuanzia tarehe 12.05.2025 mpaka tarehe 16.05.2025 katika vituo saba vilivyoko katika mikoa ya Dar Es Salaam, Dodoma, Mwanza, Arusha, Kilimanjaro na Mbeya na kimoja kikiwepo Zanzibar.

Jumla ya watahiniwa 1,464 walidahiwa kufanya mitihani hii kuanzia ngazi ya stasha-hada ya taaluma ya ununuzi na ugavi mpaka hatua ya utafiti (research).

Bodi ya Wataalamu wa Ununuzi na Ugavi (PSPTB), kupitia Kurugenzi ya Maendeleo ya Taaluma(DPD), ina jukumu la msingi la kusimamia na kuendeleza ubora wa taaluma ya ununuzi na ugavi nchini. Katika mwaka wa fedha 2024/2025, Kurugenzi hii imeendelea kutekeleza majukumu yake kwa mafanikio makubwa kupitia shughuli mbalimbali zikiwemo usajili wa wanachama wapya, utoaji wa mafunzo ya kitaaluma, utoaji wa huduma za ushauri elekezi na uratibu wa kongamano la mwaka la wataalamu wa ununuzi na ugavi.

1. USAJILI WA WANACHAMA

Tangu kuanzishwa kwa PSPTB mwaka 2007, jumla ya wanachama 18,544 wamesajiliwa rasmi. Wanachama hawa wamegawanyika katika madaraja mbalimbali kulingana na vigezo vya kitaaluma vilivyowekwa na Bodi. Wanachama 1,026 wamesajiliwa katika daraja la Authorized (AU), 1,610 katika daraja la Approved (AP), 11,263 katika daraja la Graduate (GP), 4634 wamesajiliwa katika Daraja la Technician (TE). Aidha, taasisi 10 zimesajiliwa kama Tuition Providers na kampuni moja ya

ushauri (Consulting Firm) nayo imesajiliwa rasmi. Takwimu hizi zinaonesha kuwa PSPTB imepiga hatua kubwa katika kujenga msingi imara wa wataalamu waliothibitishwa kitaaluma.

2. MAFUNZO YA MAENDELEO YA TAALUMA (CPD) NA MAFUNZO YA NDANI (TAILOR-MADE TRAINING)

Katika mwaka wa fedha 2024/2025, PSPTB imeendelea kutoa mafunzo mbalimbali kwa ajili ya kukuza ujuzi wa wataalamu wa ununuzi na ugavi nchini. Mafunzo haya yalikusishwa warsha (CPD workshops), mafunzo ya ndani (tailor-made training), huduma za ushauri elekezi, na kongamano la mwaka 2024.

Katika kipindi husika, PSPTB iliendesha jumla ya warsha 20 na mafunzo ya ndani 19. Mafunzo haya yalikuwa na jumla ya washiriki 1,603, idadi ambayo ni zaidi ya lengo la awali la washiriki 1,000. Hii ni sawa na asilimia 160 ya lengo na ni kielelezo cha mwendeleo mkubwa kutoka kwa wataalamu wa taaluma hii katika kujifunza na kuongeza maarifa yao ya kazi.

3. HUDUMA ZA USHAURI ELEKEZI

PSPTB ilitoa huduma za ushauri elekezi kwa Mamlaka ya Mapato Tanzania (TRA), ambapo wafanyakazi 150 walihudhuria mafunzo na ushauri uliotolewa. Ushauri huu ulikuwa na lengo la kusaidia taasisi hiyo kuboresha mfumo wake wa ununuzi na ugavi kwa kuzingatia sheria, kanuni, na viwango bora vya kitaaluma.

4. KONGAMANO LA MWAKA LA WATAALAMU WA UNUNUZI NA UGAVI LA 15

PSPTB iliratibu kwa mafanikio makubwa Kongamano la 15 la mwaka la wataalamu wa ununuzi na ugavi lililofanyika katika ukumbi wa AICC, Arusha, kuanzia tarehe 17 hadi 19

Desemba 2024. Kongamano hilo lilikuwa na kaulimbiu isemayo: "Mabadiliko ya Ununuzi na Mnyororo wa Ugavi kwa Usimamizi Bora wa Rasilimali (Procurement and Supply Chain Transformation for effective Management of Resources)."

Kongamano hili lilivakutanisha wataalamu wa kada mbalimbali za ununuzi na ugavi kutoka sekta ya umma na binafsi, wataalamu wa taaluma, washauri, na wadau wengine. Jumla ya washiriki 1,981 walihudhuria kongamano hilo, ikiwa ni asilimia 99.05 ya lengo la washiriki 2,000 waliokuwa wamepangwa.

Lengo kuu la kongamano hilo lilikuwa ni kuhamasisha mijadala ya kitaaluma, kuendeleza utafiti, kubadilishana uzoefu na kushauri maboresho ya mifumo ya ununuzi na ugavi katika taasisi mbalimbali nchini.

5. TAARIFA YA UKAGUZI WA TAASISI ZA UMMA NA BINAFSI

Katika mwaka wa fedha 2024/2025, PSPTB ilifanya ukaguzi wa taasisi za umma na binafsi katika mikoa 13, ambapo taasisi 227 zilifanyiwa tathmini ya uzingatiaji wa sheria ya usajili wa wataalamu. Jumla ya watumishi 1,120 waliokuwa wakitekeleza majukumu ya ununuzi na ugavi walibainika, kati yao 1,008 walikuwa wamesajiliwa rasmi na PSPTB, huku 113 wanafanya kazi hizo bila kusajiliwa na PSPTB. PSPTB imeandaa kushauri hatua stahiki dhidi ya wote waliobainika kukiuka masharti ya sheria kwa lengo la kuimarisha uadilifu na weledi katika taaluma ya ununuzi na ugavi nchini.

HITIMISHO

Kupitia mafanikio yaliyopatikana katika mwaka wa fedha 2024/2025, Kurugenzi ya Maendeleo ya Taaluma ya PSPTB inaendelea kuwa mstari wa mbele katika kuhakikisha taaluma ya ununuzi na ugavi inaendelezwa kwa mujibu wa viwango vya kitaaluma vya kimataifa.

Mkuu wa Kitengo cha TEHAMA

Katika nafasi yangu kama Mkuu wa Kitengo cha TEHAMA katika Bodi ya Wataalamu wa Ununuzi na Ugavi (PSPTB), niliongoza mchakato wa mageuzi ya kidijitali uliolenga kuboresha huduma za usajili na uthibitisho wa kitaaluma. Mnamo mwaka 2017, tulibaini ucheleweshaji mkubwa na kutoendana kwa ufanisi katika taratibu zetu za usajili na uth-

ibitisho wa kitaaluma zilizokuwa zikifanywa kwa mikono, hali iliyokuwa ikidhoofisha utoaji wa huduma na kuridhika kwa wadau.

Kama hatua ya kukabiliana na changamoto hizi, kufikia Septemba 2019, PSPTB ilizindua mfumo wa mtandaoni wa usajili na uthibitisho wa kitaaluma (<https://registration.pspbt.go.tz/>), ambao ulibadilisha taratibu za kutumia karatasi na kuongeza ufanisi kwa kiasi kikubwa.

Hatua muhimu zilizochangia mafanikio haya zilijumuisha tathmini ya kina ya mahitaji ikihusisha idara mbalimbali ili kubaini mahitaji ya mfumo. Niliratibu na kusimamia timu ya wataalamu wa fani mbalimbali wakiwemo watengenezaji wa mfumo, wamiliki wa mchakato, na washauri wa nje. Mfumo huu uliwawezesha waombaji kufuatilia hali ya usajili wao kwa wakati halisi. Ili kuwawezesha malipo ya kidijitali, tuliunganisha mfumo na njia za malipo kupitia benki na simu za mkononi kupitia Mfumo wa Serikali wa Malipo ya Kielektroniki (GePG).

Matokeo yalikuwa makubwa: muda wa

kushughulikia maombi ulipungua kutoka wiki tatu hadi chini ya siku tano, na upatikanaji wa huduma uliongezeka kwa asilimia 70%, hasa kwa wataalamu walioko nje ya Dar es Salaam na Dodoma. Maoni baada ya utekelezaji yalionesha kuridhika zaidi kwa wateja. Mradi huu uliunua hadhi ya PSPTB kama taasisi ya umma inayobuni na kuweka mfano kwa taasisi nyingine za udhibiti nchini Tanzania.

Kama Mkuu wa Kitengo, nina jukumu la kuoanisha mikakati ya TEHAMA na malengo mapana ya PSPTB. Majukumu yangu ni pamoja na kuongoza juhudi za mabadiliko ya kidijitali, kuelekeza mipango ya TEHAMA, na kukuza utamaduni unaoendeshwa na teknolojia katika idara zote. Kwa kuendesha mchakato wa kiotomatiki na kidijitali, tunarahisisha upatikanaji wa data kwa wakati halisi na kufanya maamuzi bora—kuimarisha nafasi ya PSPTB kama mdhibiti mwenye mtazamo wa mbele.

Mkuu wa Kitengo cha Huduma za sheria

Katika kutekeleza majukumu yake ya msingi, Kitengo cha huduma za Sheria cha Bodi ya Wataalamu wa Ununuzi na Ugavi (PSPTB), kimeendelea kuwa nguzo muhimu katika kuhakikisha kuwa shughuli zote za kitaasisi zinaendeshwa kwa mujibu wa sheria, kanuni, taratibu na maadili ya taaluma ya ununuzi na ugavi. Katika mwaka wa fedha 2023/2024 hadi 2024/2025, Kitengo katika utendaji kazi wake kinazingatia maeneo makuu manne ambayo ni: usimamizi wa mikataba, uimarishaji wa ushirikiano wa kitaasisi kupitia mikataba ya makubaliano (MoUs), usimamizi wa maadili ya kitaaluma, pamoja na mapendekezo ya mabadiliko ya sheria ya PSPTB ili kuendana na mazingira ya sasa ya kitaaluma.

1. Mikataba na Makubaliano ya Kitaasisi

Katika kipindi husika, PSPTB kupitia Kitengo cha Sheria imefanikiwa kusaini jumla ya mikataba 26. Mikataba hii inahusisha maeneo mbalimbali kama vile huduma za ushauri wa kitaalumu, utafiti, mafunzo, pamoja na usimamizi wa miradi mbalimbali ya taasisi. Baadhi ya mikataba hiyo imekamiliwa kwa mafanikio, wakati mingine inaendelea kutekelezwa.

Vilevile, PSPTB imefanikiwa kuingia mika-

taba ya makubaliano ya ushirikiano (MoUs) na taasisi mbalimbali kwa lengo la kuimarisha weledi, maadili, na ufanisi wa utekelezaji wa majukumu ya kitaaluma. Miongoni mwa taasisi hizo ni:

a) Mamlaka ya Rufaa za Zabuni za Umma (PPAA): Ushirikiano huu unalenga kupata nakala za maamuzi ya rufaa zinazotokana na mchakato wa ununuzi wa umma zenye masuala ya kimaadili ili kusaidia uchunguzi na hatua za kisheria dhidi ya wataalamu wa ununuzi na ugavi wanaokiuka maadili.

b) Chuo Kikuu cha Dar es Salaam (UDSM): Ushirikiano huu umeelekezwa katika nyanja za utafiti wa kitaaluma, mafunzo ya pamoja na ushauri elekezi kwa ajili ya maendeleo ya taaluma.

c) Bodi ya Mikopo ya Elimu ya Juu (HESLB): MoU hii inalenga kuboresha utoaji na upatikanaji wa taarifa za wataalamu wa ununuzi na ugavi na kuunganisha mifumo ya kielektroniki baina ya taasisi hizi katika utekelezaji wa majukumu yao.

Makubaliano haya yamejikita katika kuimarisha weledi wa wataalamu na ufanisi wa Bodi katika kuwahudumia wataalamu wa ununuzi na ugavi.

2. Usimamizi wa Kesi za Maadili na Makosa ya Jinai

Katika mwaka wa fedha 2023/2024, PSPTB kupitia kitengo cha huduma za Sheria kilipokea na kushughulikia jumla ya tuhuma 32 dhidi ya wataalamu wa ununuzi waliodaiwa kukiuka maadili ya taaluma. Baada ya uchunguzi wa kina kufanyika, watu 15 walikutwa na hatia na kuadhibiwa kwa mujibu wa Sheria ya Bodi ya Wataalamu na Wasanifu wa Ununuzi na Ugavi Sura 179 na Kanuni za Maadili wataalamu wa Ununuzi na ugavi za mwaka 2009 (Gazeti la serikali namba 365).

Aidha, Kitengo kilipokea majina ya wa-

tumishi 109 ambao ni waajiriwa wa taasisi za umma na binafsi lakini hawajasajiliwa na PSPTB ilhali wanajihusisha na shughuli za ununuzi na ugavi. Kitendo hiki ni ukiukwaji wa kifungu cha 46(2) na (3) cha Sheria ya PSPTB. Hatua mbalimbali zimeanza kuchukuliwa dhidi ya wahusika, ikiwemo kutoa taarifa kwa waajiri wao. Wananchi na waajiri wote wanakumbushwa kuwa ni kosa la jinai kuajiri au kumtumia mtu asiyesajiliwa kwa kazi za kitaaluma za ununuzi na ugavi.

3. Mapendekezo ya Mabadiliko ya Sheria ya PSPTB Pamoja na Kanuni zake

Sheria ya PSPTB ya mwaka 2007 imekuwa ikitumika kwa zaidi ya miaka kumi bila kufanyika maboresho makubwa. Marekebisho ya mwisho yaliyofanyika mwaka 2014 yalikuwa ya sehemu ndogo na hayakugusa maeneo muhimu kama vile:

- Mfumo wa usajili wa wataalamu kwa kutumia teknolojia mpya;
- Mahitaji ya kusasisha vigezo vya usajili wa wataalamu wa viwango tofauti;
- Uboreshaji wa mamlaka ya nidhamu na mifumo ya ukaguzi wa wataalamu.

Kitengo cha huduma za Sheria kinaendelea kutayarisha na kuwasilisha mapendekezo ya kina ya mabadiliko ya kanuni na sheria kwa Wizara ya Fedha kwa ajili ya hatua zaidi za kisheria. Lengoni kuhakikisha sheria ya PSPTB inakuwa shirikishi, ya kisasa na inayojibu mahitaji ya sasa ya wadau, wanataalamu na taasisi zinazotegemea huduma ya wataalamu wa ununuzi na ugavi.

4. Hitimisho

Kitengo cha huduma za Sheria cha PSPTB kinaendelea kuwahimiza wataalamu wote wa ununuzi na ugavi nchini kuzingatia viwango vya juu vya maadili na kuendelea kusajiliwa kwa mujibu wa sheria.

Wanafunzi 680 wafaulu mitihani ya PSPTB

Bodi ya Wataalam wa Ununuzi na Ugavi (PSPTB) imetangaza matokeo ya mitihani ya 30 ya kitaaluma ya PSPTB iliyofanyika Mwezi May, 2025 katika vituo vinane nchini ikiwemo vituo saba Tanzania Bara na kituo kimoja kwa Tanzania Visiwani.

Akizungumza na waandishi wa habari Mkurugenzi Mtendaji wa PSPTB Godfred Mbanyi amesema kuwa watahiniwa 1506, walijisajili kwaajili ya mitihani hiyo huku waliofanya mitihani ni wanafunzi 1,421, wanafunzi 680 sawa na asilimia 47.9 wamefaulu kati ya watahiniwa 1,421 waliofanya mitihani ya kitaaluma, ilihali Watahiniwa 610 sawa na asilimia 42.9 wanarudia masomo yao na watahiniwa 131 sawa na asilimia 9.2 wamefeli na wataanza upya masomo yao katika ngazi husika.

Mbanyi amesema kuwa baadhi ya masomo yameonesha kufanywa vizuri na watahiniwa hii ikiwa ni ishara njema kwa taifa katika majadiliano ya biashara na ununuzi hususani katika mikataba ya kimataifa kama ambavyo Rais Dkt. Samia Suluhu Hassan amekuwa akisisitiza nchi kuwa na wajuzi wenye uwezo wa kufanya majadiliano yenye tija kwa taifa.

Bodi imewapongeza wanafunzi waliofanya vizuri kwenye mitihani pamoja na wakufunzi kwa kuendelea kusimamia maadili na miongozo ya taaluma ya ununuzi na ugavi, huku pia ikitoa wito kwa wanafunzi ambao hawakufanya vizuri kwenye mitihani yao kuendelea na maandalizi kwaajili ya kujiandaa kwa awamu nyingine ya mitihani hiyo ambayo inatarajiwa kufanyika mwezi Novemba, 2025 huku ikiwaomba wanafunzi walioimaliza vyuo kujisajili kwaajili ya kufanya mitihani hiyo.

Membership Registration Criteria

1.1 Honorary Fellowship

The awardee shall meet the criteria narrated hereunder: -

- a) Must have a remarkable contribution and outstanding records of achievements in the profession and the Board as determined by the Board of Directors;
- b) Must be a person of good records and competence in professional conduct;
- c) Must demonstrate leadership qualities and mentorship roles in the Profession;
- d) Must have strong influence policy and strategy making decisions in the Profession;
- e) Must be a person with a proven experience in the Profession with at least 15 years;
- a) Holder of a Bachelor's Degree or Transcript in Procurement and Supply Management from training Institutions accredited by the Board or
- b) Holder of Graduate Professional/Professional level III in Procurement and Supply Management issued by the Board or
- c) Any equivalent professional qualification recognized by the Board,
- d) Foreign or foreign-trained in Procurement and Supply programs must have; -
 - i) Registered by relevant professional Board responsible for procurement and supply,
 - ii) Possess a certificate of competence issued by the Board.

1.2 Authorized Procurement and Supply Professional **The applicant in this category must possess the following qualifications; -**

- a) Must be a PSPTB registered Approved Procurement and Supply professional,
- b) Must have attained 40 CPD hours per annum as prescribed in the CPD Policy,
- c) Must have proven good records and competence in professional conduct,
- d) Must demonstrate professional competence or at least 5 years from the time of registered as Approved Procurement and Supply Professional, and
- e) Must present to the Board the Procurement and Supply projects performed as prescribed by the Board.

1.3 Approved Procurement and Supply Professional **A person registered in this category shall pose the following qualifications; -**

- a) Holder of a CPSP Certificate or equivalent qualifications recognized by the Board,
- b) Must be a PSPTB registered Graduate Procurement and Supply professional,
- c) Must have attained at least 40 CPD hours per annum as prescribed in the CPD Policy,
- d) Must have proven good records and competence in professional conduct.
- e) The applicant should have at least three years of proven professional practice in the Graduate category.
- f) Foreign or foreign-trained in Procurement and Supply programs must have; -
 - i) Registered by relevant professional Board responsible for procurement and supply,
 - ii) Possess a certificate of competence issued by the Board.

1.4 Graduate Procurement and Supply Professional **For a person to be registered in this category of professional registration must have the following qualifications.**

1.5 Procurement and Supply Technician **For a person to be registered in this category of Technicians registration must have the following qualifications.**

- a) Holder of an Ordinary Diploma in Procurement and Supply Management from a learning institution recognized by the Board or;
- b) Holder of Professional Diploma in Procurement and Supply Management or Procurement and Supply Foundation Management Certificate issued by the Board or;
- c) Any equivalent professional qualification recognized by the Board,
- d) Foreign or foreign-trained in Procurement and Supply programs must have; -
 - i) Registered by relevant professional Board responsible for procurement and supply,
 - ii) Possess a certificate of competence issued by the Board.

1.6 Affiliate Member

- a) Must hold at least a degree in any discipline from a recognized higher learning institution,
- b) Must be registered by his/her respective Professional Board or association, if any.
- c) Must possess a certificate of competence issued by the Board.
- d) Must have a proven track of good records in professional conduct.

1.7 Procurement and Supply Consulting Firms

- a) Must have a Certificate of Registration from the registrar of Business Name or competent Authority,
- b) Must have a valid Business License issued by the relevant competent Authority,
- c) Must have a relevant and valid Tax Clearance Certificate,
- d) Proof of a proper business premise and physical address,

Membership Registration Criteria

- e) For Sole Proprietor, the applicant must be registered in Approved or Authorized with a valid Practicing License,
- f) For Partnership, at least one of the partners must be registered in Approved or Authorized with a valid Practicing License, and
- g) Must employ procurement and supply professionals registered by PSPTB to undertake procurement and supply related matters.

1.8 Procurement and Supply Training Providers

- a) Must satisfy the conditions set by the Tanzania Commission of Universities (TCU) or The National Council for Technical and Vocational Education and Training (NACTVET),
- b) Must have a Certificate of Registration from the registrar of Business Name or competent authority,
- c) Submit a valid Business License issued by the relevant competent authority (if any),
- d) Must have a relevant and valid Tax Clearance Certificate,
- e) Must submit proof of ownership/lease agreement on premises,
- f) Trainers must be registered by PSPTB at least in the Approved category, and
- g) Trainers must have experience of at least three years in professional practice or training.

2.0 REGISTRATION OF PRACTICING LICENSE

Must be a registered professional and intend to engage in the business of procurement and supply practices.

- a) Must have attained at least 40 CPD hours per annum as prescribed in the CPD Policy,
- b) Must have proven good records and competence in professional conduct.
- c) Foreign or foreign-trained in Procurement and Supply programs must have; -
 - i) Registered by relevant professional Board responsible for procurement and supply,
 - ii) Possess a certificate of competence issued by the Board.

DEREGISTRATION, RESIGNATION AND RESTORATION

The registration status of a registered procurement and supply technician, professional, affiliate member, procurement and supply consulting firm or training provider may be terminated in case of breach for professional code of ethics and conduct or fails to comply with the requirements and conditions of PSPTB Act and its regulation as prescribed hereunder;

1.1 Deregistration

The Board may remove from the Register the name of a procurement and supply professional or technician or procure-

ment and supply consulting firm or training provider or affiliate member who does not comply with the requirements and conditions of registration under the PSPTB Act, Regulations and membership registration criteria. In addition, failed to pay annual fees for a period exceeding twenty four months without any notice, member has resigned or died.

1.2 Resignation

A registered person or Procurement and Supply Consulting firm or training provider may resign from the category by sending his resignation in writing to the Executive Director, after payment of all the fees and installments of registration fee due from him, including that for the current year. A registered person's name or firm or provider shall be removed from the Register from the date on which his resignation becomes effective.

1.3 Restoration

A registered member whose name was removed from the register; his name may be restored to the Register by submitting to the Executive Director a duly completed application for restoration of his name to the register on a format prescribed by the Board. In addition, the member must submit acceptable documentary evidence that he complies with conditions under which he was registered. The applicant shall pay the restoration fee as prescribed by the Board and pays such amounts in respect of arrears of fee, if any. Furthermore, the Board may restore the applicant to the category of registration to which he formerly if he satisfies the Board that he is worthy of re-registration and he has paid the amounts in respect of registration fee and arrears of fees as the Board may determine.
